# **Registration Information**

Welcome to Good Shepherd Preschool! We are delighted to have you join us for the upcoming school year. Please read the following information completely. Once you have read the information, complete the registration form, and return it to the Director, Christine Linso or your child's teacher. **Please retain this page for future reference**.

- All students entering a program must be the age of their program by September 1, 2024.
- Class assignment is at the discretion of the director and teachers only.
- Enrollment: A <u>non-refundable</u> registration fee is required to secure your child's placement.
  - \$55.00 for returning students
  - \$60.00 for new students
  - Reduced <u>registration fees</u> for multiple enrollments: Two returning (\$75.00), Two new (\$85.00), One new and one returning (\$80.00), Three or more (\$140.00)
  - An escrow payment of one month's tuition is due by June 1<sup>st</sup>, 2024 to maintain your child's placement, or at the time of registration if occurring after June 1<sup>st</sup>. This payment is <u>non-refundable</u> after July 15, 2024 and will be held in escrow and applied to the ninth month's payment, that of May 2024. No reduction of tuition can be made for absences, illness, or voluntary withdrawal from school following July 15, 2024. There are NO exceptions to this policy!
  - The school year runs from September-May. Tuition is collected in 9 monthly payments by check. Tuition will be due on the first day of the month for 8 months

starting in September. A \$10.00 late fee will be applied if payment is not received by the 5<sup>th</sup> of the month. September's tuition will be due the first week of school, after the parent meeting. Information concerning the start of school will be mailed in August.

- All students must be up to date on vaccinations to attend school.
  - Immunization records and allergy information should be submitted with your escrow tuition payment before the start of school. No child will be permitted to start school without having their records on file.
  - Returning students have until September 30, 2024 to submit updated records.
  - o Required vaccinations: MMR, DPT, Polio and Hepatitis B
- Activity fees for each program are due by October 1, 2024.
  - o 2s: \$20.00 3s: \$55.00 4s: \$65.00 Enrichment: \$30.00

### **2024-2025 Preschool Program Offerings**

Half day classes are held 9:00-11:30 a.m.

OR

Full day classes are held 9:00-2:30 p.m.

#### **Program Descriptions**

#### 2 Year Old Program:

The 2-year-old program is a playgroup style of learning. Play centered development with lots of imagination. Children enjoy a basic routine including circle time, art, and gym. We will explore number and letter awareness, colors, and shapes but the focus is on fun and socializing with peers.

## 3 Year Old Program:

The Christian based 3-year-old program introduces a little more structure but keeps all the fun! Children benefit from whole group and individual instruction, free play, gym, music, art, and chapel. Ageappropriate Handwriting Without Tears is included in the curriculum. Field trips and special school events are highlights of the year.

**NEWLY ADDED 3's afternoon only session**: The afternoon session is similar to the morning with some minor differences. Music and chapel will take place within the classroom rather than Fellowship Hall. Field trips, if any, will be upon afternoon availability of the facility and paid a la carte (no upfront activity fee due at registration).

#### 4 Year Old Program:

We provide a traditional Pre-K education that is Christian based and focuses on development of basic literacy, math concepts, social studies, science, and social skills. Kindergarten readiness, positive peer culture, and learning through play are major components of this program. The curriculum includes Handwriting Without Tears as an additional support for school readiness. Special trips and programs are favorite traditions. Children also enjoy gym, art, music, and chapel.

#### Friday Enrichment Program (4's only):

Friday Enrichment builds and extends on our traditional 4-year-old program by incorporating STEAM concepts (science, technology, engineering, art, math). Program availability based upon enrollment.
